## Privacy Policy - Adopted by Club Committee 8 January 2024

#### Who We are...

We are Chippenham Sailing and Canoeing Club.

### What type of information does the Club collect?

We receive, collect and store any information Visitors, other Users (whether members or not) enter on our Website or provide us in any other way.

We also collect information about Users Members and Former Members on our Membership Platform (LoveAdmin or any replacement Membership Platform)

We may collect personally identifiable information including:

- Name, any images of you and personal profile
- location/times/place(s) disclosed by you
- Email
- Password
- Communications
- Membership information
- Fees and payment details (including credit card information)
- Event orders (paid or unpaid)
- Comments and feedback

In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information.

We may use software tools to measure and collect Website session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

#### How do we collect information?

When you conduct a transaction on our Website, as part of the process, we collect personal information you give us such as your name, address and email address. Your personal information will be used for the specific reasons stated above only.

When you engage with the Membership platform or Club email system records are created.

We may also from time to time collect data via surveys etc.

### Why do we collect such personal information?

We collect such non-personal and personal Information for the following purposes:

- To provide and operate our club membership services;
- To provide our Users with ongoing customer assistance and technical support;
- To be able to contact our Visitors and Users with general or personalized servicerelated notices and messages;
- To create aggregated statistical data and other aggregated and/or inferred Nonpersonal Information, which we or our business partners may use to provide and improve our respective services;
- To comply with any applicable laws and regulations.

# How do we store, use, share and disclose our Website visitors' personal information?

Our club Website is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to provide our web-based services to you and facilitate off-line club activities.

Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com (and which may be used by the club through its Website) adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

# How do we store, use, share and disclose our Members' personal information?

In addition to the storage, use, sharing and disclosure in the paragraph above related to the Clubs Website, we also store, use, share and disclose membership or activity records which result from your use of the Website may be stored, used and shared with

- our Email Providers (Zoho or a replacement mail provider)
- Our Membership Platform
- The National Governing Bodies with whom we affiliate (British Canoeing and Royal Yachting Association)

#### **Images**

#### How do we communicate with our site visitors?

We may contact you regarding any profile or member account (whether hosted on Wix, LoveAdmin or replacement Membership Platform) to troubleshoot problems with your account, to resolve a dispute, to collect fees or monies owed, to poll your opinions through surveys or questionnaires, to send updates about our club, or as otherwise necessary to contact you to enforce our membership rules, applicable national laws, and any agreement

we may have with you. For these purposes we may contact you via email, telephone, text messages, and postal mail.

Members and visitors can opt out of receiving routine service-related messages by ending their club subscription – please contact membership@scc-com.

## **Cookies and other tracking tools**

We have a legitimate interest in maintaining and improving our Website and use standard Wix Website performance tools and for this purpose. #### **Cookies: Third-Party Services**

#### How long we retain your data

For users that register on our Membership Platform store the personal information they provide in their user profile for the duration of their membership and a reasonable period afterwards. The retention period may vary and could be indefinite, for example, if the member has yet to collect a boat left in storage in the compound. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Membership platform administrators can also see and edit that information.

For users that register on our Website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

If you leave a comment or participate in community chat, the comment and its metadata may be retained indefinitely.

#### What rights you have over your data

You have the following rights in relation to the personal information we hold about you:

- to access your personal information
- to be provided with information about how your personal information is processed
- to have your personal information corrected
- to have your personal information erased. Please be aware that erasing your personal information may prevent us from continuing to provide services to you.
- to object to or restrict how your personal information is processed
- to have your personal information transferred to yourself or to another business in certain circumstances
